

#### **About Las Virgenes MWD**








#### State, Regional and Local Actions

#### Normal Supply Conditions



MUNICIPAL EST. 1958

- June 15, 2021 District declared a Stage 1 Water Shortage Alert. Messaging to customers begins
- July 8, 2021 Governor issued EO N-10-21 calling for 15 percent voluntary reductions
- July 20, 2021 District declared a Stage 2 Water Shortage Warning and called for 15% voluntary reduction in water use
- August 17, 2021 MWD issued Water Supply Alert
- November 2, 2021 District Board Declared local drought emergency and Stage 3 - Water Shortage Emergency

#### State, Regional and Local Actions (cont.)

 November 16, 2021 – District Board modifies penalty structure for exceedances during droughts

#### (USE OF FLOW RESTRICTORS APPROVED)

- March 18, 2022 CADWR announces reduction in SWP allocation from 15% to 5%
- March 28, 2022 Governor Newsom issued N-7-22, calling for intensified efforts to "further conserve water"
- April 5, 2022 Board reduces outdoor water budgets to 50%, effective May 1st
- April 26, 2022 MWD adopts Emergency Water Conservation Program (one day per week watering)
- June1, 2022 Current Restrictions Effective





## Why Flow Restrictors?

- State of Emergency and finite water supplies conservation mandates
- \$\$ penalties do not always do the trick
- Equity/fairness
- Worked during Covid for non-pays
- We've done everything....last resort!

- Impacts to households/businesses
- Legal opinion/liability
- Modification of the LVMWD Code penalty structure
- Developing an Implementation Plan
  - Who, what, where, when, why, how
- Execution and modification of the Plan



#### Impacts to Service

**<u>RESTRICTED</u>** (note: this is the maximum flow. All valves were fully opened)

SIZE HOLE	TEST	TIME TO FI	LL FLOW RATE
5/64"	7.48 gal	6min24sec	1.15 gallons per minute maximum flow

#### **NOT RESTRICTED** (note: these are standard "bench" flow tests)

SIZE METER	TEST	TIME TO FILL	FLOW RATE
3/4"	7.48 gal	2min24sec	3 gallons per minute med flow test
3/4"	7.48 gal	20seconds	22 gallons per minute high flow test



## Impacts to Service (Cont.)

<u>Please be advised that a water flow restriction</u> <u>device will limit water supply to basic essential</u> <u>needs only.</u> The restricted water supply will <u>not</u> be sufficient for most non-essential services, including your landscape irrigation system and certain appliances. It is your responsibility to ensure and/or prevent any damage to your property and/or appliances once a flow restriction device is installed. Additionally, <u>fire suppression systems may not</u> <u>function as intended</u>.





# Legal Opinion

- District's position is that the use of flow restriction devices is a "last resort"
- Customers have many opportunities to avoid and warnings
- \$\$ penalties alone do not work (in our case)
- State of Emergency (local and state conservation mandates) provides protection from liability/inverse condemnation





### **Penalties**

- 1<sup>st</sup> penalty: A warning only
- 2<sup>nd</sup> penalty: An extra charge of \$2.50 per unit of water (748 gallons) over 150% of water budget
- 3<sup>rd</sup> penalty: An extra charge of \$5.00 per unit....
- Customers are also subject to the installation of a flow restriction device
- 4<sup>th</sup> penalty: .... \$7.50 per unit.....
- 5<sup>th</sup> and subsequent penalties: .... \$10.00 per unit....

# **Opportunities to Avoid**

- Request a free on site water use survey
- Sign and submit a "Commitment Form"
- Reduce water use (stay w/in 150% of water budget)
- Appeal (w/in 15 days of a penalty notice)



Request for Water Use Survey & Commitment to the Efficient Use of Water

- Am requesting a free water use survey in order to find more ways that I can reduce water use on my property. Upon submission of a signed Request for Water Use Survey & Commitment to the Efficient Use of Water, I understand that the District will endeavor to schedule me for a survey at my property to be conducted within the next thirty (30) days. If due to a high volume of requests for surveys, I am not scheduled and/or the District is unable to conduct the survey, I understand that it will still receive four (4) additional monthly exceedances as described in #B below, but only if f fulfill the other requirements described on this form.
- Have been informed of and/or am aware of the current drought and water supply conditions that prompted the declaration of a local State of Emergency due to a severe water shortage that warrants a significant reduction in my water use, specifically outdoor watering of landscapes. - 3. Am aware that my outdoor water budget for my property was reduced by 25 percent (drought factor of 0.75) effective December 1, 2021 and to 50 percent (drought factor of 0.5) effective May 1, 2022 and that I need to significantly reduce my outdoor watering by at least an equal or greater amount that will allow me to stay within my adjusted water budget. I understand that I may need to continue adjusting the number of days each week, including one day maximum effective June 1, and the amount of time that my irrigation system is turned on in order to avoid future monetary penalities, including the installation of a flow restriction device.
- 4. Have reviewed the Water Efficiency Checklist provided by the District or available on the District's website and understand the options available to me to use water more efficiently that will help me to stay within my water budget each month.
- 5. Agree to install a weather-based irrigation control device through the District's Rachio<sup>MA</sup> incentive program at the time of the survey (if I don't already have one) or install a similar type of device outside of the District's incentive program within the next sixty (60) calender days that will help me to reduce my outdoor water use and to make adjustments to the programming of the device as needed to account for the latest drought factor or other restrictions that are adopted by the District (i.e. one-day a week watering). - Agree to register for the WaterSmart Portal and to utilize the portal, if I have not already, in order to help me to reduce my water use and to stay within my water budget. Website access for information at: <u>https://www.lvmwd.com/watersmart</u>
- Understand that I can go to resources readily available by the District to monitor the drought and water supply conditions, for updated information on adjustments to water budgets and other restrictions, and the latest information concerning penalties and appeals for exceedances. Website access at: <u>https://www.hrmd.com/droughtresponse</u>.
- 8. Acknowledge that if I submit this form and fulfill the above requirements<sup>•</sup>, I can incur four (4) more monthly exceedances beyond what is permitted by the LVMWD Code, one-time only during activation of stage 3 of the Water Shortage Contingency Plan, before being subject to the installation of a flow restriction device but will still incur monetary penalties. I understand that the first installation would be for at least 14 calendar days and up to 30 calendar days and that future installations would be for progressively longer periods of time (3 months and 6 months), should they occur.
- 9. Understand that I must, at a minimum, demonstrate each month after submitting this form, significant improvement in the efficiency of my water use and show progress towards staying within my budget in order for the District to honor the granting of the additional exceedances as described herein to avoid the installation of a flow restriction device.
- Acknowledge that should the District activate Stage 4 Critical Water Shortage, I am not to use any water to irrigate on my property or for other outdoor purposes except as what may be permitted by law at the time that Stage 4 is activated.




# **Door Tagging**

- Fire Suppression Systems May Not Function
- District accepts no liability for any damages
- Start date and "window" for installation
- Door tag fees

- Installation/removal costs
- Hefty fines for tampering
- Last and final opportunity to avoid an installation
- Contact info to bypass the busy front office phones

Once installed, the device will remain in place for no less than 14 calendar days and up to 30 calendar days the first time it is installed, 90 calendar days the second time, and 180 calendar days the third and subsequent times that it is installed. Noticing/door tag, flow restrictor installation/ removal fees will also be applied to your account.

Noticing door tag fee:	\$100.00
Installation/removal fee (each)	\$100.00

Other penalties may apply in accordance with 7-1.114 of the LVMWD Administrative Code:

Broken meter seal or lock:	\$200.00	
Illegal water consumption / Unauthorized removal of the device:	\$2,500 min.	

You may be eligible to defer this or future installations and be allowed additional exceedances if you sign and submit the Request for Water Use Survey & Commitment to the Efficient Use of Water Form located at the website below prior to the earliest date scheduled for the installation. Conditions apply.



#### **Flow Restriction Device Durations**

- 1<sup>st</sup> Occurrence: Device stays in 2-4 weeks
- 2<sup>nd</sup> Occurrence: Device stays in 3 months (yikes!)
- 3<sup>rd</sup> & more: 6 months (double yikes!)





# Statistics (as of December 1, 2022)

- 4<sup>th</sup> exceedance notices: 3,499 (16.7%)
- Door tags for flow restriction: 500
- Total flow restriction devices installed: 205
- Flow restriction devices installed a 2<sup>nd</sup> time (90 days): 16
- No lawsuits / TROs (yet)





- District-wide conservation
  - 37% average (June 1. Dec. 1 2022)
  - 41% in November 2022
- GPCD Reduction
  - 249 average (June 1. Dec. 1 2021)
  - 149 average (June 1. Dec. 1 2022)
- ~83% of customers have not had 4 or more exceedances since January 2022
- ~60% of customers within budget in recent months (fluctuates)
- No penalties by MWD and outdoor watering ban delayed





### Lessons Learned / Do's and Don'ts

Do:

- Get the support of your elected officials
- Get your own legal opinion / work with legal council
- Limit the # of devices / prioritize to keep the Program manageable with available resources
- Give lots of warnings/ opportunities to reduce water use
- Have an administrative appeal process in place
- Coordinate/communicate to local Fire Department / Code Enforcement
- Adjust the size of restriction holes if indoor water flows are inadequate
- Get ready for PRRs / Media Inquiries



#### Lessons Learned / Do's and Don'ts

#### **Do Not:**

- Set installation targets that are not manageable / exceed available resources (you do not have to install them all to have an impact)
- Overcomplicate Program roll-out and on-going implementation
- "Abuse" the Program (use with caution and as a last resort)
- Give preferential treatment to any customer (be consistent)
- Cave to the threat of lawsuits (stick to your guns)
